# Item 1 opening and welcome

IS welcomes all participants to the meeting. He states that the Annual Meeting has been convened according to the statutes and that the invitation and the agenda was sent out in time. The Annual Meeting has a quorum.

He reminds all that the vote for the election of the Board will remain open until 10.30 CEST.

# Item 2 Adoption of the agenda

The agenda is adopted.

## **Item 3 Adoption of the minutes**

The minutes of the last Annual Meeting on 6 September 2020 were sent in advance. There are no comments or requests for changes. Sonja Greiner (European Choral Association) moves to adopt the minutes, Kimmo Mattila (Confédération Internationale des Accordeonistes) seconds the adoption of the minutes.

The minutes of the Annual Meeting on 6 September 2020 are adopted.

## **Item 4 Reports**

#### a. Annual report 2020

VL presents the Annual Report of 2020 with an overview of the events organised by the EMC including the European Forum on Music Online 2020 and COVID-19 lounges, the policy and advocacy topics and activities, an overview of the communication tools of the EMC such as the new podcast "Music Webs" as well as an overview of the three projects that the EMC is involved in – SHIFT, MOST, CreativeShift and a pilot project on measuring the cultural and creative sectors in the EU.

VL thanks the staff for their efforts during this very difficult year.

# b. Activities in the frame of "Year 4" of the EU networking grant – amendments related to the pandemic

The amendments made to Year 4 of the networking grant are included in the meeting documents. RJ highlights that the main change concerned the European Forum on Music 2020 which was scheduled to take place in June 2020 in Bonn but had to be transformed to a series of online events.

# c. Financial Report

## 1. Results 2020

WM explains that the finances for 2020 are good in particular for the challenges due to the pandemic. He thanks the members for paying their membership fees in these difficult times. The main changes made to the budget concern the shift from travel to staff costs.

RJ reminds participants that the extension of Year 4 of the network grant was explained during the last Annual Meeting in September 2020.

# 2. Report of the Internal Auditor

The internal auditor Daniel Kellerhals (DK) points to his report that is included in the meeting documents in which he concludes that the accounts were kept in an orderly manner in accordance with the statutes and tasks.

IS thanks DK for his work as internal auditor over several years.

# 3. Discharge of the Board

Sonja Greiner moves to discharge the Board.

With no votes against and one abstention the Board is discharged for 2020.

## d. IMC Report

SF presents the IMC report and recounts the 3 pillars of IMC's work: value-driven, network of networks and project organisation.

The Culture at Work Africa project will come to an end with a series of closing events.

The IMC participated in the most recent edition of the UNESCO Conference of the Parties of the 2005 Convention. The IMC is also a member of the Steering Committee of the civil society group.

SF reports that arts education is coming back to the UNESCO programme as an intersector programme between culture and education. A summit of cultural ministers is planned for March/April 2022 in Mexico and the IMC along with other organisations is claiming a space for civil society at this conference.

IMC President AK thanks the IMC secretariat and the EMC Board and secretariat for their work over the last year. He stresses the need to unite as a musical ecosystem to achieve our goals.

## **Item 5 Personnel**

SD presents an organigramme of the current EMC staff. Carolyn Auclair (CA) has moved to Canada and will continue to work for the SHIFT project until end of January 2022 with 20 hours per week. The staff structure might change again depending on future projects.

## **Item 6 Membership**

## a. Applications/withdrawals.

There have been no new applications or withdrawals since the last Annual Meeting in September 2020.

## b. Membership Strategy

A first meeting of a think tank on membership organised by the International Music Council will take place in autumn 2021. The EMC will be represented by SD and DZ. The other Regional Groups of the IMC will also send two representatives. The think tank will review the membership categories and define relationships with partners.

All EMC members are encouraged to review their information in the membership directory on the EMC website and send updates if necessary. The EMC secretariat will further look into the possibility of organising a members' lounge focused on the membership categories and EMC membership.

The 52 VOTING DELEGATES correspond to 122 TOTAL WEIGHTED VOTES. The voting delegates had to register at the online voting tool "election runner" in order to guarantee a secure and secret voting.

Not all registered voting delegates cast their votes this leads to the total of 110 weighted votes cast for the Board elections.

As chair of the Election Committee, EB, explains the voting procedure. The Election Committee was made up of EB, Gill Maxwell (GM) from the Scottish Music Centre, Helena de Winter from REMA, WM and SD.

The voting procedure was opened on 1 June 2021 through the online tool Election Runner and was closed on 6 June 2021 at 11.00 CEST. All voting delegates received a link and a unique voting ID.

The Board consists of 7 members. The current Board consists of 8 members because two candidates had received the same number of votes at the past elections in 2018, therefore, both candidates were co-opted to the Board.

The mandate of EMC President IS ends after having completed the maximum amount of 4 mandates, EB is not standing for re-election.

The Election Committee had discussed criteria for Board candidates and members including that it would be good to have a female president. These criteria were presented to the Board and the membership in advance. Because of the extraordinary circumstances, the current Board members were asked to announce in advance if they were willing to take on new roles if they were elected again. VL has confirmed that she is ready and motivated to take on the role of President. AG has announced that she is willing to run for Vice-President and WM has confirmed that he would run as Treasurer again. No other candidates have expressed interest in these positions.

EB announces that the vote was closed at 11.00 CEST and that there is a valid result. The results were checked by EB, SD, RJ, MN and GM.

There are two categories of weighted votes. National Music Councils and European/International Organisations each have 3 votes whereas National Specialised Organisations have 1 vote.

46 voting delegates have cast their vote out of the 52 voting delegates registered to vote. With the weighted votes, this brings the maximum amount of votes cast to 110.

IS congratulates the 7 candidates elected to the Board and thanks all candidates for standing in the election. He also thanks EB and the election committee.

The Annual Meeting is taking a break while the newly elected Board convenes for a first meeting to elect the Vice-President and the Treasurer and to nominate a candidate for President to be elected by the Annual Meeting of members.

The newly elected Board returns from their meeting and announce that Audrey Guerre has been elected as Vice-President and Willem van Moort as Treasurer.

## b. Internal auditor

According to the statutes, the EMC members will first vote on the main and then on the substitute

internal auditor. The candidate for the internal auditor is Stef Coninx (SC), the candidate for the substitute internal auditor is Sonja Greiner (SG).

The Annual Meeting votes on Stef Coninx as main internal auditor. With no votes against and no abstentions, Stef Coninx is unanimously elected as internal auditor.

The Annual Meeting votes on Sonja Greiner as substitute internal auditor. With no votes against and no abstentions, Sonja Greiner is elected as substitute internal auditor.

## c. EMC President

The Board announces that they nominate Victoria Liedbergius (VL) as President of the Board. There are no other candidates. The vote takes place on election runner. All voting delegates present in the meeting receive a link and unique voting ID to cast their vote.

The 38 VOTING DELEGATES correspond to 94 TOTAL WEIGHTED VOTES.

Not all registered voting delegates cast their votes this leads to the total of 75 weighted votes cast for the elections as EMC President.

On the ballot, voting delegates can either select yes, no or abstain for Victoria Liedbergius as EMC President.

The voting delegates have 10 minutes to cast their vote. Afterwards, it is announced that the vote is closed. The validity of the vote is checked and confirmed by EB, GM, SD, RJ and MN.

31 voting delegates have cast their vote out of 38 voting delegates eligible to vote adding up to a maximum weighted votes of 75 out of 94 maximum eligible weighted votes. With 69 votes in favour, 6 abstentions and no votes against, Victoria Liedbergius is elected as President of the EMC Board.

IS congratulates VL on her new position and wishes the newly elected board every success.

## **Item 8 EMC strategic aims**

SD opens the discussion on the strategic aims of the EMC that are important for the EMC and future planning including the upcoming Creative Europe network application. This could include an increased focus on the topics that will be highlighted more in the European Agenda for Music (EAM) – gender equality, freedom of expression and climate change – but also (digital) recovery of the music sector, inclusion and diversity and the social aspect of the music sector or innovation. Many of the members give their input and provide examples either as an oral contribution or in the chat. SD thanks the members for their input.

## a. EMC workplan 2021-2022

The activities of the EMC workplan for 2021 - 2022 were covered in the discussions on Items 11 - 17.

## b. Budget 2021/2022

RJ provides explanations for the budget of 2021/2022 that is included in the Annual Meeting documents. The final accounts show the membership fees that were invoiced whereas the reduction or waive is included in the administrative costs as well as dropped invoices in the expenditure.

Staff costs for 2021 had to be balanced by reducing external staff costs and the reduction of CA's position. External staff costs are mostly made up of the IMC Music World News, policy work by SF as well as external support for the website and communication material. In 2020 this included the EFM Online Series workshop with the Green Music Initiative and GO Group.

The EMC received additional funding from the German state ministry for culture for the EAM update. The financial situation for 2021 is save but it is not clear yet where the EMC stands financially for 2022. An emergency budget was created in case the EMC does not receive a new EU network grant.

WM stresses that the financial situation for 2021 is good and for the next years it is still to be seen. The Board had a good exchange about the financial situation and cash flow. If the EMC will no longer receive network funding and personnel costs have to be reduced, this would be first discussed in the Board who will then inform the members. In reference to the auditor's report, some members ask about the possibility of an economic model for the EMC. WM suggests that this can be taken on by a new Board.

With no votes against and no abstentions, the budget is unanimously adopted.

IS thanks WM for his work as treasurer.

## Item 10 EU networking application

The strategic aims presented and discussed under Item 8 will shape and be taken into consideration for the EU networking application. It will also take into account the replies to the survey among EMC members regarding the application.

The call is expected to be published in the following week.

(Note: the EMC application under the network strand of the Creative Europe programme with the title "Sustain Music" was successful)

## Item 11 European Agenda for Music

JG stresses that the EAM remains the central document for the EMC and that as a living document the EAM process continues. Introductory sentences from the EAM were used to promote the EFM highlighting its relevance.

## a. Web publication and testimonials

The EAM website will be further updated with examples how the EAM was put into practice on a dedicated sub-page. For this it is important to receive the input of EMC members and further supporters of the EAM. JG invites the participants of the AM to share examples of how they use the EAM.

- Stéphane Grosclaude talks about the French translation, visibility of the EAM, systematically mentioning it. It is a slow process but it is growing into people's minds. He uses it as an advocacy tool for cultural rights.
- JG confirms that it is a slow process but that it is effective. It is also used for other sectors, e.g. theatre.
- WM and SC talk about the Dutch/Flemish translation and a big conference in the Netherlands last year where the EAM was presented to all music school directors. SC has used the EAM for moderating a working group on diversity. He encourages others to not only think of the EAM as a whole but that sometimes a focus on specific parts is beneficial.
- The European Choral Association used it as inspiration and guideline for the discussion and further development of their own strategy and for the Singtank that is working on a vision and strategy for the sector of collective singing in general.
- AEC, EMU and EAS have a working group SCHEME that is aimed at bringing the EAM into action which was also a topic of a webinar in cooperation with the EMC in early 2021. The EAM highlights the common ground of the educational networks.

#### b. Translations

So far, translations of the EAM into six languages are available. Based on her own experience of translating the EAM into Polish, JG emphasises that this is a process worth doing.

## c. Additions to current text version

With the successful application for additional BKM (German state ministry for culture) funding, the EAM will be broadened to include the effects of the pandemic. The EMC has subcontracted the IMC with a first literature review which was done by the IMC intern Sam King. His research of first findings is available in the meeting documents. Updates of the EAM should also stronger reflect climate action, gender equality and freedom of expression.

SD thanks JG and the others for their contribution.

## **Item 12 Music and Cultural policy**

## a. European Union

1. Future EU funding programmes (Creative Europe, Erasmus+, Horizon)

AG reflects on the funding session during the EFM with Barbara Gessler and insights into Creative Europe and Horizon Europe. Creative Europe has an increased budget which should lead to more funded cooperation projects. There are no major changes in the programme but a new scope with medium-sized cooperation projects and sectorial actions for music. Through the dialogue with the music sector more meetings with the Commission can also be expected. Horizon Europe will also offer several funding opportunities for the cultural sector in Cluster 2 "Creativity, Culture, Inclusion". A strong focus is on heritage but there could be possibilities to develop the idea of a European Music Observatory further.

## 2. Next Generation EU, recovery instrument

The Recovery and Resilience Facility (RRF) is also in place where a campaign that the EMC also supported advocated for at least 2% for culture. It remains to be seen what will be implemented in the national plans.

#### 3. Voices of Culture SDGs

SD adds that the EMC will continue to apply for participation in the Structured Dialogue "Voices of Culture" as it has in the past and continuously consult its members on the input for the discussions and report. The Brainstorming Report for the SDGs has already been published.

#### 4. Voices of Culture Status of the Artist

The Voices of Culture Status of the Artist Brainstorming Report is expected to be published by the end of June.

#### b. UNESCO

The updates on music and cultural policy at UNESCO were covered in Item 4b Report of the IMC.

#### Item 13 events

The EFM 2021 was completed successfully the day prior to the AM. RJ explains that it remains difficult to plan events and that the EMC is hopeful that in the future travel will be possible again. It will be further reflected how this will look like sustainably and accessibly. Possibilities for the EFM in the coming years might be Timisoara (RO) in 2022 in the framework of MOST and 2023 in Moscow (RU) together with the IMC. More information about events is included in the meeting documents. The planning of the events will depend on how the pandemic develops.

#### **Item 14 Publications**

Information on the publications is available in the meeting documents. There are no further questions by the members.

## Item 15 Fellowship

IS reaffirms EMC's commitment to the Fellowship Programme which had to be adjusted due to the travel and meeting restrictions caused by the pandemic.

# d. Music AIRE – An Innovative Recovery for Europe (pending application in the frame of Music Moves Europe, EMC as consortium partner)

MK recalls that the call published in July 2020 was a combination of the previously planned calls in Music Moves Europe for 2020. The core task of the project is to distribute grants to the music sector. Together with Inova+ as a lead partner, the EMC handed in an application to develop new funding models for digital, green and just & resilient recovery. Throughout the application process, the EMC consulted with other European music networks – including members and non-members. There were open questions that remained during the application process until the selection announcement at the end of April. After a conversation with the European Commission (DG EAC), Inova+ and EMC handed in replies to some questions that were raised in a joint meeting. More concrete planning

cannot start before the contract is signed and EMC hopes to start working on the project in September with the first calls for proposal to be published in late autumn. The larger music sector will be involved in the planning stages for this.

IS congratulates SD and the team for a successful project application and negotiation.
